➤ **Essential Qualification**

- (a) Degree in Ayurveda Medicine (BAMS) from a University established by law or statutory/Faculty/Examining body of India Medicine or equivalent as recognized under Indian Medicine Central Council Act 1970 or Statutory State Board/Council of equivalent recognized under the Indian Medicine Central Council Act 1970.
- (b) A Post Graduate (PG) Degree in the subject/specialty concerned included in the schedule of India Medicine Central Council Act 1970.
- (c) **DQ(Desirable qualification)**: Reading, writing and speaking knowledge of Sanskrit.

➤ **Modalities**

- (a) Scrutiny has been done on the basis of the scrutiny Report generated by the Computer system as per information filled in by the candidates in the online application form and the documents/certificate uploaded with ORA.
- (b) Experience acquired as Part time/hourly basis/daily wages/visiting/Guest faculty/ Apprentice/ trainee/consultant/Honorary /Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.
- (c) The scrutiny of the application has been done strictly as per the provisions of **Recruitment Rules (RRs)** for the post in question.
- (d) Total experience claimed by the candidates in the relevant field has been taken into consideration, if supported by necessary certificates.
- (e) As huge response of **206 candidates against 02 (01-UR & 01-OBC)** posts, hence criteria invoked to **07 years for UR candidates** in teaching/clinical experience for the post after PG degree.
- (f) OBC certificate issued by Govt of NCT Delhi has only been considered.

➤ **Short-listing Criteria for :-**

- (i) **UR (Un-reserved) category candidates**: EQA(i) + EQA (ii) + **07 years** in teaching/clinical experience in Ras Shastra evum Bhalshajya Kalpana for the post after PG degree.
- (ii) **OBC category candidates**: EQA(i) + EQA (ii).
