1.	Rajasthan	Physical photo copy of OMR sheets filled by candidates during exam is handed over to candidates for review. But this sometimes created doubts in mind of candidates that how these responses interpreted by the scoring system were maintained at RPSC. Therefore, many candidates earlier had to seek their evaluated OMR sheets responses through RTI. In response to this and to make system more transparent, RPSC have developed system to show candidates evaluated OMR sheet responses online through its Official Web Portal. Candidates can now pay a nominal fee and download their evaluated sheets online from their home without seeking such information through RTI. This has reduced the number of RTI received at RPSC and added to overall satisfaction to the Candidate's.
2.	Tripura	i) TPSC has introduced Aadhar Enabled Online System for filling application in all examinations conducted by the TPSC. The system will facilitate submission of applications by the candidates from their locations all over the country and they will get the advantage of one time registration with TPSC which may be referred to in future also. The system also provides for tracking examination centres through mobile GPR system.
		ii) TPSC has simplified the procedure for selection of candidates to the post of Tripura Civil Service and Tripura Police Service Grade-II. The revised procedure consisting of 6 papers only against existing 56 papers, seeks to provide a simplified, digital friendly, speedier and more transparent one.
		iii) The existing process of Combined Competitive Examination for Miscellaneous Posts has been simplified. The simplifies procedure seeks to provide only one written examination instead of two examinations. It would be more transparent, speedier, digital friendly and administratively expedient.

Telangana	i) The Commission has been implementing the facility of One Time Registration (OTR) for all the recruitments which reduces hassle of submitting papers and estimated expenditure for the candidates. A candidate's data is stored at a place and it can be used while filling an On-line application which makes it easy to file individual applications in a few minutes. From the registration of candidate in dot.R system till the completion of selection, candidate will be receiving SMS communication from TSPSC office giving different types of information.  <b><u>Candidates Facilitation Services:</u></b>  a) <u>Help Desk:</u> TSPSC has developed the interactive website where candidate can send queries to helpdesk or clarify the doubts by calling the phone number.

		b) <u>Web Journal</u> : TSPSC has launched a first bilingual quarterly web journal “ TSPSC UDYOGA SAMACHARAM “ on the occasion of its 3 <sup>rd</sup> Anniversary in the month of December, 2017. On the occasion, Telangana State PSC has released its 100 <sup>th</sup> Notification.
		ii) <u>Video Record through Drone</u> : TSPSC in its Endeavour to adopt the latest available technology to further enhance the reliability and transparency in the conduct of exams has taken a step forward by using the drone camera to capture the live conduct of Physical Efficiency Test conducted in connection with recruitment of the posts of Excise Constables.
		iii) <u>Live Streaming on Smart Phone</u> : The events were held at Excise Academy in Hyderabad, Telangana State and drone was used for video recording of events, which was also watched live on smart phones by using the web link and monitored by watching live video stream at TSPSC Command Centre. This system helps in further increasing the transparency and reliability in the conduct of the physical exams.
		iv) <u>Special service for onfield , ontime and online update of data</u> : TSPC has also used a special service provided on TSPSC website for entering the details of the candidates onfield, ontime and online and the same updated on the website and the candidate was informed instantly whether he was qualified or disqualified.

The marks and other details of all candidates are published after finalization of keys and in this manners transparency is maintained to the highest level.
