11. **General Branch**

- i) Provision of Wi-Fi facility in Old Adviser's Suites:- As part of upgradation of digital infrastructure of the Commission and to facilitate the Advisers and Guests visiting in connection with Commission work, high speed Wi-Fi facility has now been provided in the Old Adviser's Suites.
- ii) Special Repair of the Old Sub-Station:- The Commission has been closely monitoring the upgradation of its physical infrastructure and is adopting newer and efficient technologies with high availability of services. As part of this initiative, the Commission has undertaken to rehabilitate, modernize and upgrade old Electric Sub-station behind Annexe Building through the nodal agency, CPWD. The Sub-Station equipments which were more than 30 years old were not only less efficient but also breaking down frequently. These panels and switch gears have been replaced with new technology panels/ switch gears. Further as part of strengthening fire safety, the old oil based transformers have been replaced by the dry type transformers.

12. Hindi Branch

- 1. During the period, two meetings of the Official Language Implementation Committee were held on 23.03.2018 and 18.06.2018 under the Chairmanship of Secretary in which progressive use of Hindi in the Commission was reviewed.
- 2. Under the various training programmes in Hindi Teaching Scheme, 08 persons were given lump sum cash awards for their outstanding performance and 08 persons were given additional advance increment.
- 3. The website is in bilingual form and updation of it, is a continuous process.
- 4. Two Hindi workshops were organized on 06th February, 2018 and 6th April, 2018 in the Commission's office, in which 42 and 30 officers/ officials participated respectively.
- 5. Quarterly Process Report/Annual Assessment Report for progressive use of official language Hindi is submitted to the Department of Official Language 'On Line' through software available at the link 'Management Information System' on the Department's Website www.rajbhasha.gov.in.

3.	Tamil Nadu	Commission has introduced a new system of obtaining the scanned copy of the original certificates of the shortlisted candidates through online mode. Candidates have to scan and upload their certificates so as to substantiate their claims made in the online					

application. After due date, the Commission will verify the certificates and call only qualified candidates possessing all certificates as per their claim in the online application. In this new process Original Certificates will be verified at the time of Oral Test/ Counseling for which the candidates have to appear in person. The task of scanning and uploading activity has been entrusted to the Arasu e-Seva Centres which are run by TACTV (Tamil Nadu Arasu Cable TV) in all taluk and district headquarters.

4. Telangana

Initiatives:-

Teacher Recruitment Test (TRT) recruitment was successfully conducted by TSPSC, which was a major challenge because of large variety in the number of subjects, mediums, categories, languages, options of candidates for other districts etc. Further it was an arduous task for TSPSC to schedule the exams in such a way that all the eligible candidates who applied for more than one post could be accommodated to appear for all the exams for which they are eligible. As such, the exams were meticulously planned and scheduled in 16 different sessions and for a total of 43 papers. For the first time TSPSC had to draw up the question papers in 7 vernacular languages besides English.

Teacher posts and its importance for candidates:-

Teacher Recruitment test is one of the most popular and eagerly awaited recruitments especially for rural candidates with B.Ed qualification. Compared with other recruitments, it is significant as a large number of rural candidates aim to get selected for Government teacher posts as they get an opportunity to serve in their local schools in their villages/ mandals and also for the respect the government teacher commands in the society at large. There was a huge demand for teacher posts, as the posts were notified after a gap of 5 years. 277373 numbers of applications were received for the TRT posts.

For the first time teachers recruitments entrusted to TSPSC:-

Ever since the formation of TSPSC, Government of Telangana have been entrusting the TSPSC with several new recruitments under Forest Department, Medical and Health Department, Agriculture Department, Telangana State Road Transport Corporation (TSRTC), Pollution Control Board, Gurukul Societies etc.

Government of Telangana also entrusted TSPSC with prestigious teachers recruitment to fill-up all the vacant teacher posts in Telangana State which earlier teacher recruitment was popularly known as DSC (District Selection Committee), where candidate must apply only for one district either to his local district or to any other district as non-local candidates. Government of Telangana with a view to have a uniform recruitment procedure for all teacher posts and to complete the recruitment at the earliest in a transparent and foolproof manner has entrusted the TRT recruitment to TSPSC for the first time.

Separate notifications issued to enable candidates to apply for

multiple posts:

To avoid confusion and for better clarity, for 8792 vacancies of teacher posts, TSPSC issued 5 separate notifications for each category of post to facilitate the candidate to apply for more than one post and for more than one medium, if they are eligible.

Earlier DSC recruitment was conducted district-wise and merit candidate has no choice to opt for any other District as the selection was confined only to that particular district. But in the TRT Notification issued by TSPSC, merit candidate has an option either to get selected in his local district or can given preference for some other district as non-local candidate.

Candidates allowed to apply for multiple posts as per his eligibility and exam conducted in 16 sessions to avoid overlapping.

The Commission has conducted the exam in 16 sessions from 24.2.2018 to 03.4.2018 by keeping in view the combination of applications received from the candidates' i.e combinations for more than one notification, for more than one subject in a single notification, for more than one medium for a single subject. Conducting of OMR based exam and **Computer Based Recruitment Test** (CBRT) exam side by side in a single day was also a big challenge for the Commission as some candidates were common for these two types of exams, but the Commission has crossed all the challenges and allotted the candidates in the nearby venues accordingly.

Bold decision to conduct the exams in CBRT mode:

TSPSC has gained sufficient expertise in the successful conduct of CBRT exam and has already conducted 31 recruitments in CBRT. As such TSPSC took up the challenge of conducting the TRT recruitment and issued notification for 8192 vacancies.

The Commission has taken a bold step to conduct 13 out of 16 sessions in CBRT mode. While preparation of schedule of examination utmost care was taken by TSPSC to avoid overlapping of exams. **Out of 48 papers of TRT, the exam for 43 papers was conducted in CBRT mode**. Out of 43 CBRT exams held, 38 exams were conducted in vernacular languages. Further the conduct of 43 CBRT exams at a single stretch was difficult and TSPSC has completed them without even a minute error.

Record created by drawing up the question paper in 8 vernacular languages:

The TSPSC has started a new trend in CBRT mode of exams by conducting the exam in 7 vernacular languages at a time besides English. It would be pertinent to mention that many other PSCs have not conducted the online exam in their own regional language but the TSPSC has reached another milestone by conducting exams in many regional languages and with a grand success.

It is a great achievement in the journey of TSPSC for excellence,

as it has never conducted the subject papers viz. Mathematics, Social Studies, Biological Science, Physical Science in other languages other than English & Telugu. The successful conduct of CBRT exam for the subjects of Mathematics, Social Studies, Biological Science, Physical Science in seven vernacular languages, which is an achievement in itself. Further conducting of online exam in Urdu has become a regular phenomenon for the TSPSC as it has conducted the exam in Urdu for 3 times upto now.

Secondary Grade Teacher (SGT) Exam challenging category with large number of subjects, medium and languages:

Secondary Grade Teacher exam is an intricate and laborious type of exam as it has different subjects, different mediums in a single paper. For preparing a single paper of SGT exam, the 12 experts from different fields are invited and the number is more if it has to be conducted in more than one medium, which was also a great challenge for the Commission.TSPSC has conducted this kind of an exam with many variations of subjects/mediums/languages.

Technical issues:

During the conduct of examination, the Commission had to resolve many technical glitches, court cases filed by the candidates, has to procure a large number of venues, identify experts from different fields and from different languages. It was indeed a onerous uphill task to conduct such a large number of online exams in a single spell for one recruitment with the meager staff of the Commission. However TSPSC stood successful in completing all the exams without any issue.

Web Journal:

TSPSC has launched its second edition of bilingual quarterly web journal "TSPSC UDYOGA SAMACHARAM" on the eve of the Retirement day of one of the Hon'ble Members of Telangana State Public Service Commission in the month of May, 2018.

5. Tripura

TPSC has introduced Online System for filling application in all examinations for direct recruitment conducted by TPSC. The system will facilitate submission of application by the candidates from their location all over the country and provide online Admit Card to the applications. The system is enabled the applicant every up to date information regarding the specific examination. The system also provides a facility to track examination centres through mobile GPR system.

The Commission also selected and finalized 15 recruitments and selected 2760 candidates out of 3041 posts. The entire process is completed within the above short period only. A significant factor to note is that all of these examinations are Computer Based Tests, held in single session and
		large number of candidates appeared in the examinations. The Commission also implemented a two level scheme of objections in publishing keys immediately after examinations, calling for objections in prescribed format, referring them to experts and there after publishing final keys and marks. The marks and other details of all candidates are published after finalization of keys and in this manner transparency is maintained to the highest level.

•			TSPSC Conducts the Departmental Tests to evaluate the proficiency of the State Government servants on latest Rules/Procedures/Acts/government orders related to their Departments with an endeavor to improve the functioning of the Government. It is mandatory for every Government Servant to pass the
			prescribed Departmental Test within a stipulated period for continuation of the service and also to get service benefits like declaration of Probation and accrual of Increments. In view of the importance of these Departmental Tests, the examinations were scheduled biannually in the months of May and November for six days. TSPSC conducts exams for a total of (153) papers pertaining to different departments.
			Till the last session (November-2017), all the Departmental Examinations are being conducted in offline mode that is Pen & Paper based OMR Objective type examinations for (126) papers and the remaining 27 examinations are held in Descriptive mode. As with the Off-Line method of examination is tedious and involves lot of man hours, consumes time in drafting of examination centers, printing of question papers, loading and unloading of important material of answer sheets to and from district centers and the said activities may not be fool proof, it is contemplated that the other alternative is to conduct the examination in COMPUTER BASED RECRUITMENT TEST (CBRT pattern) where the question papers will be in encrypted form, secured method of testing as the handling and transfer of sensitive material will be encrypted form with multiple password protection and it nullifies any kind of malpractices occurs in Off-Line mode.
		ii)	The TSPSC is the first Commission in the country to have conducted the CBRT examination for around 30,000 candidates in one session. Keeping in view the expertise gained by TSPSC in the successful conduct of CBRT Exams, Commission proposed to conduct all the Departmental examinations in CBRT mode. In view of all the pro & cons, the Commission arrived at a decision which is aimed to revamp and reform the present system of Off-Line pen and paper OMR based written examination and to roll over to On-Line/CBRT method of examination for departmental Tests also revealing that the entire exercise of On-Line examination (CBRT) is not only transparent but quick and devoid of complex frills associated with Off-Line examination right from printing of question papers to valuation and declaration of results. The proposed CBRT method of departmental examination was conducted for May-2018 session in the month of July, 2018.
