## X. PROJECT / SCHEME / STUDY/SURVEY OR INNOVATIVE WORK DONE BY THE STATE PUBLIC SERVICE COMMISSIONS.

- Nagaland i) Nagaland PSC has taken a major step towards One Time Registration (OTR) of candidates, which is a preliminary process of uploading a candidate's information and supporting documents to the Commission through Nagaland e-District portal. This process eliminates submission of documents and scrutiny of applications for future examinations of the Commission.
- 2. Odisha i) Odisha PSC has initiated office Automation by implementing "e- Office" in the organization to facilitate prompt movement of files and quick decision making.
  - OPSC has invited RFP for going ahead with conducting computer based tests in different examinations other than scheduled examination "Odisha Civil Service, Odisha Judicial Service and Odisha Forest Service examinations."

#### 3. Rajasthan i) On-Screen Marking System (OSM) for RAS (Mains) Exam,2018

On Screen Marking is the process of applying technology to the process of marking/scoring descriptive answer scripts with a view to improve quality, flexibility, efficiency and transparency while making the scoring process easier for evaluators. Earlier this was implemented for RAS, 2018 Main Examination successfully with innovation to use the Book scanners with validation of barcodes along with biometric based authentication. This process improves quality, flexibility, efficiency and transparency while making the scoring process easier for evaluators as well as to gear up the process of declaration of result on time.

#### ii) DAK IPO (Indian Postal Order) Management System

In-house application developed by IT Cell for making entries of IPO's at Receipt/Dispatch Cell (DAK Cell) by concerned staff so that necessary reporting may be made available for Post Office and Accounts Cell. This system provides various reports with data exporting options in Excel format e.g. Examination wise receipt of fees in the shape of IPO. This application helps in speedy process of IPOs and also checks the dates of IPOs within the stipulated time.

#### iii) Exam Process Tracking and Management System

In-house development has been made by IT Cell for managing the internal process of any examination along with tracking the process with initial level i.e. notification to recommendations to Government. This application authenticates each concerned Cell to put remarks in the entire process for the pendency. Higher authorities can check the pendency at every stage of the Recruitment process and take action accordingly.

#### **B-** Reforms in Recruitment Process

#### 1. Weightage of Marks obtained in Screening Test -

i) In case of direct recruitment wherein selection was made through interview alone, the Commission used to conduct Screening Tests to shortlist the candidates in case where number of applications were received in large numbers. In general, three times the number of the candidates were declared successful against the post notified. The marks obtained in Screening Test were not considered at the time of final selection. The prescribed maximum marks for interview were 100.

ii) To make above recruitment process more transparent, in the year 2019-20, the Commission decided in its full Commission's meeting to **divide the interview marks in three parts** - academic qualification, weightage of marks obtained in Screening Test and marks obtained in viva-voce test.

#### 2. <u>Constitution of Pre-Litigation Committee –</u>

(i) Every year several recruitment advertisements are issued by the Commission in response to which candidates apply in large number for various posts. In the course of the recruitment process at various levels, dissatisfied candidates on several grounds approaches the Hon'ble Courts to get certain relief. This causes burden of Litigations. To reduce the increasing number of suits filed in the Hon'ble Courts, the Commission have decided to constitute a Pre Litigation Committee on 01.03.2019 so that the complaints may be disposed off at the Commission's level.

#### 3. <u>Counseling to gear up Recruitment Process</u> –

(i) The Commission initiated counseling process to expedite the recruitment process. Earlier, detailed application forms were sought from the candidates along with the copies of documents regarding academic qualifications. category. experience etc. who were declared successful for interview or finally selected in case if recruitment is done through written examinations only. The detailed forms were submitted by candidates by post which used to take at least one month before reaching the concerning section. This was followed by tedious and time consuming process of scrutiny of application forms. Thereafter, interviews are conducted and recommendations were sent to government.

ii) To reduce the time lag between declaration of results & Interview/recommendation the Commission initiated the process of

counseling in which candidates are invited personally with their documents. Teams were constituted comprising officers and employees of the commission and officers and employees of the concerned department for which recruitment is being done. These teams simultaneously perform the checking, scrutiny and verification of documents with original documents in presence of candidate himself. So that all sorts of anomalies with regard to qualification, category, experience etc. can be resolved on the spot.

iii) The Counseling process has certainly reduced the time in completing the recruitment procedure. Now, the Commission is able to send the recommendations at the earliest. A record maximum 1000 application forms were scrutinized in a day which have been possible due to motivation and encouragement of the Hon'ble Chairman and secretary to the commission.

#### 4. Tripura i) Introduction of CCTV in Commission's Premises-

The Commission has upgraded its own Examination Hall by installation of CCTV for secured, transparent and maintaining proper Examination system to be monitored centrally. Further, the CCTV has also been installed at key locations in the building for 24 hours monitoring and maintaining security.

#### Centralized Evaluation System:-

ii) The Commission has introduced Centralized Evaluation System for speedy completion of Recruitment process with utmost security in TPSC building itself. Earlier the answer scripts used to be sent to the Examiners at their place for evaluation, who used to take their own time in evaluation and also there was risk of its loss and maintaining confidentiality. Now the evaluation is done in-house in TPSC building with utmost security and confidentiality and in a time bound manner. This has increased the credibility of the system and considerably reduced the time for completing the examination process within a year.


