10. HINDI BRANCH:

- i) During this period, Hindi branch of UPSC remain actively engaged in propagating the use of Hindi in various branches of UPSC. Meetings of Official Language Implementation Committee were held in every quarter under the Chairmanship of the Secretary in which various measures to increase the progressive use of Hindi in the Commission was reviewed. The last two quarterly meetings of the Official Language Committee were held on 22.03.2023 and 12.07.2023.
- ii) Under Hindi Teaching Scheme, 09 staff have been given one advance increment and cash award to 03 staff for passing Hindi Typing Exam with distinction.
- iii) The website of the Commission is in bilingual form and all materials are being uploaded bilingually. Its updation is a continuous process.
- iv) Two Hindi workshops were organized on 06.03.2023 and 12.06.2023 in the Commission in which 34 Officials participated. Their feedback was very encouraging. To motivate the staff & officers of UPSC to do their official work in Hindi, a Guide of Official Language Rules has been prepared and circulated amongst the staff & officers of the UPSC participating in workshops.

11. GENERAL:

For the convenience of candidates appearing for interview, a separate entry gate has been made operational with effect from Civil Services 2022 (PT) Board starting from 31.01.2023.

12. SERVICES-II:

The 24th National Conference of Chairpersons of State Public Service Commissions was held on 22nd and 23rd April, 2023 at Lucknow, Uttar Pradesh.

13. WELFARE:

- i) Yoga classes are being conducted in the premises of UPSC for the Officers/Staff of the Commission since 16th January, 2023 by Morarji Desai National Institute of Yoga, New Delhi.

- i) The Commission has successfully completed Group-I Prelims Examinations evaluation process within 21 days like never before and declared results.

- ii) Odisha PSC has implemented Visitor Management System (VMS) which keeps track of each and every visitor who visits OPSC for some or other reasons. The details of the visitor along with her/his photo, purpose of visit, Officer to whom wants to meet, time of entry/exit are recorded. Being a constitutional and sensitive organization, the VMS helps in increasing accountability and implements a safeguard to its functioning.

6. Rajasthan

- i) Dynamic Center Update after Roll No. Generation Process: This module developed and implemented through State Recruitment Portal. This feature enables to update and change a candidate's centre of any examination after generation/allocation of his/her roll no. to a certain centre. Examination Centre can also be changed after Roll no. generation. It is used when in case of the whole centre is changed for management reason or candidate changed their subject or post.
- ii) One-Time Document Verification Process (ODV): This module is developed and implemented through State Recruitment Portal. One-Time Document Verification is the process through which various documents of candidates selected in one or more recruitment are verified only once to simplify the scrutiny process and to save time and effort spent on documentation verification. Mainly this process is required and executed at the time when the candidate has qualified the exam. A Detailed-Cum-Scrutiny form will be open for candidate to fill online the requirements accordingly. Documents uploaded by candidate are verified One-Time basis and stored in OTR of the candidate. So, the candidates need not to verify their documents for each recruitment.




