EXAMINATION, 2019

Based on the results of the written examination of the Indian Economic Service / Indian Statistical Service Examination, 2019 held by the UNION PUBLIC SERVICE COMMISSION from 28th to 30th June, 2019 followed by interviews for Personality Test in December, 2019 and January, 2020, the following are the lists, in order of merit, of the candidates who have been recommended for appointment to the posts in Indian Economic Service and Indian Statistical Service.

In case the candidate fails to submit the requisite documents as required by the Commission within this period, their candidature will be cancelled and no further correspondence would be entertained in this regard.
