ESSENTIAL QUALIFICATIONS(EQs):

Essential Qualifications (EQ)

A. EDUCATIONAL

(i) Bachelors degree in Unani Medicine from a recognized University or Statutory State Board or Council or Faculty of Indian Medicine from a recognized under the National Commission for Indian System of Medicine Act, 2020 (14 of 2020).

(ii) Enrolment on the Central Register of Indian Medicine or State Register of Indian Medicine.

MODALITIES:

- (i) Scrutiny has been done on the basis of the scrutiny report generated by the Computer System as per the information by the candidates in their online applications form and the documents certified uploaded with Online Recruitment Application.
- (ii) Experience as part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. However, Experience on contract basis in relevant field and experience while pursuing the higher degree has been considered for scrutiny.
- (iii) Total experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.
- (iv) The applications received from the category other than general category has been considered in the general category as the posts are not reserved for any category.

➤ **Short-Listing Criteria:**

EQA (a) & (b) + PG Degree in Unani Medicine + 02 years teaching/ clinical/ research experience in Unani Medicine.

1. The initial scrutiny details for the same were uploaded to the Commission website on 07/02/2024 and rejected candidates were asked to represent their rejection within 10 days to the Commission. However, a list of provisionally shortlisted candidates was also uploaded to submit the requisite documents to the Commission within the same time limit.
2. One candidate (Roll No1: 181) was asked to submit deficient documents and reply from her was received and consequently, she has been shortlisted.
3. 03 representation from rejected candidates were received against their rejection for the post and the same have been examined as under:
