### **ESSENTIAL QUALIFICATIONS(EQs):**

### A. EDUCATION-

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-Graduate degree or diploma in the concerned speciality or super speciality mentioned in Section-A or Section-B of Schedule VI or equivalent i.e. Doctor of Medicine (Anaesthesiology) or Master of Surgery (Anaesthesiology) or Diplomate National Board (Anaesthesiology) or Post Graduate Diploma in Anaesthesiology.
- **B. Experience** Experience At least three years' experience in the concerned Specialty or Super Specialty after obtaining the Post Graduate degree or five years' experience in the concerned Specialty or Super Specialty after obtaining the Post Graduate diploma.

The total numbers of effective applications is 113. All the applications have been considered.

#### **MODALITIES:**

(i) Scrutiny has been done online, first on the basis of the report generated by the Computer System as per the information filled up/claims made therein by the candidates in their online recruitment applications.

- (ii) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field and experience while pursuing the higher degree has been considered for scrutiny.
- (iii) Total Experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.
- (iv) The applications received from the SC category candidates have been considered in the general category as post is not reserved for SC category.

## > Short-Listing Criteria:

above after obtaining the first Post Graduate Degree or 6 years' after obtaining the Post

- 2. The 17 candidates (Roll Nos: 01, 15, 28, 32, 36, 42, 49, 63, 74, 79, 93, 94, 96, 102, 107, 109 & 112) were asked to submit the documents and reply from 08 candidates Roll Nos: 28, 32, 42, 63, 74, 79, 93 & 107 have been received so far and consequently have been shortlisted.
- 3. Remaining 09 candidates (Roll Nos. 01, 15, 36, 49, 94, 96, 102, 109 & 112) who have not responded, their rejection is maintained.
- 4. 12 candidates **Roll Nos.** 05, 29, 31, 37, 45, 51, 59, 60, 88, 90, 99 & 159, who have represented against their rejection, are not found eligible. Therefore, rejection of these 12 candidates is maintained. The representations of these candidates are examined as under:
