**ESSENTIAL QUALIFICATIONS:**

**(A) EDUCATIONAL:**

- (i) Degree in Ayurveda Medicine from a University established by law or statutory board/faculty/examining body of Indian Medicine or equivalent as recognized under Indian Medicine Central Council Act 1970.
- (ii) A Post Graduate Degree in the subject/specialty concerned included in the schedule of Indian Medicine Central Council Act 1970.

The total numbers of effective applications is 166. All the applications have been considered.

**Modalities**

- (i) Preliminary Scrutiny has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the Online Recruitment Application.
- (ii) In the Advertisement, applicants were asked to upload all certificates/documents along with online applications;

however, many applicants have not uploaded complete certificates/documents.

(iii) Since the number of candidates are large i.e. 166 for 02 (SC-01 & UR-01) posts and to restrict the number of applications for General category candidates for 01-UR post 06 years experience (teaching or clinical) in the specialty of Ayurveda- Prasuti Tantra evum Stri Roga is enhanced. As the sufficient number of candidates found in the specialty of Prasuti Tantra evum Stri Roga, such candidates who have PG qualification claimed in allied specialty of Shalya Tantra have not been considered.

(iv) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.
