ESSENTIAL QUALIFICATIONS:

A. EDUCATIONAL

(i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956, (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfil the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956),

(ii) Post-graduate Degree or Diploma in the concerned Speciality or Super-speciality mentioned in Section-A or Section-B in Schedule VI i.e., Master of Surgery (Ophthalmology) or Doctor of Medicine (Ophthalmology) or Diplomate National Board (Ophthalmology) or Post Graduate Diploma in Ophthalmology or Post Graduate Diploma in Ophthalmic Medicine and Surgery.

B. EXPERIENCE

(iii) Three years' experience in the concerned Speciality or super-speciality after obtaining the Post-graduate degree or 5 years' experience after obtaining the Post-graduate Diploma.

Modalities

(i) Preliminary Scrutiny(PS) has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the Online Recruitment Application (ORA) and ORA are prima-facie found eligible on the basis of information filled up/claims made in ORA.

(ii) PS has been done strictly in accordance with essential educational and experience qualifications prescribed for the post and the conditions laid down in the for the post.

(iii) The candidates who do not possess the relevant essential education qualifications have been rejected as "**LEQ-A**" (Lacking essential Qualification-Academic), likewise, if essential experience "**EQ-B**" is not in the relevant field as specified in the Recruitment Rules (RR) of the post or relevant experience is less than the required period; such candidates have been rejected under "**LEQ-B**" (Lacking essential Qualification-

experience). Candidates who do not meet the enhanced criteria of experience have been rejected as **'LEC' (Lacking enhanced criteria of experience)**.

(iv) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience "Medical consultant" on regular nature of appointment has been considered as valid experience. Experience on contract basis in the relevant field has been considered.

(v) Some of the candidates can be rejected under more than one category. They have been rejected under category considered as most appropriate.

(vi) Experience certificate is prescribed proforma as per the advertisement (advt) have been considered. Wherever the applicants have not submitted experience certificate in prescribed proforma, their experience certificate have been considered on merit.

(vii) In the **50% relaxation** in experience criteria has been provided to **two ST** candidates as there was no sufficient number of candidates from that category.

(viii) In advt, applicants were asked to upload all certificates/documents along with ORA; however, some applicants have not uploaded complete certificate/documents. Those candidates who have claimed essential Qualifications and fulfil short-listing criteria but have not uploaded relevant documents have been provisionally short-listed and suggested to **"Call for documents" (CFD)**.

(ix) As the number of UR candidates were 51 for two UR posts, EQ(B) has been enhanced from 3 years and above 3 years 3 months and above for PG Medical Degree candidates (MS/MD) with the concerned speciality, o rationalize the number of candidates around the prescribed limit of **24 candidates for 2-3 vacancies as per Commission's norms**.

(x) OBC candidates (Roll No 52) claimed Creamy Layer status has been treated as General Candidate and processed as per the short-listing criteria adopted for General candidates.

(xi) The post for which no application has been received or no candidates could be shortlisted has been declared as **"Infertuous"** at scrutiny stage.

The total numbers of effective applications is 89. All the applications have been considered.

➤ **Short-Listing Criteria:**

➤ **Criterion For ST** - EQ(A)(i)+EQA(ii) + EQ(B) with relaxation upto 50% of the prescribed experience criteria.

➤ **Criterion For SC** EQ(A)(i)+EQA(ii) + EQ(B).

➤ **Criterion For OBC** EQ(A)(i)+EQA(ii) + EQ(B).

Criterion For UR:- EQ(A)(i)+EQA(ii) + EQ(B) experience raised to 3 years 3 months and above after obtaining PG degree and 5 years 3 months & above after obtaining PG Diploma.
